Installation	Manufacturing, distribution, and end of life of 3% scrap originated from off-cuts during installation and end of life of packaging. The product does not require earthing.
Use stage	This product does not require energy consumption, maintenance, or additional products during its use.
End of life	Transport of end-of-life product to a treatment centre and its treatment (according to the PSR, given the lifetime of these cable trays, no specific data can be used to model the end of life, and the default scenario of 100% incineration with no energy recovery must be considered)
